Subject - Inexplicable lifetime and influence of "The San Diego Statement." "The San Diego Statement" was never approved by the D.A. WSC, yet it reappears, year after year, like a zombie. What keeps it alive? "The San Diego Statement" has no legitimacy: it was never approved or even voted on by the full Conference of Debtors Anonymous. It was one person's opinion about D.A.

Some chronology - The so-called "San Diego Statement" was first mentioned by Carla J., the Chair of the General Service Board, in her "Report from the Chair" at the D.A. World Service Conference in San Diego CA in 2006. [2006 Annual Report, page 12, available on [debtorsanonymous.org](http://debtorsanonymous.org)] It was then adopted by vote of the 12 members of the GSB. [I have no written documentation of this.] At

the 2007 WSC in Sturbridge MA, the new Chair, Carol B, repeated the statement in her "Report from the Chair," reported that the GSB had voted to submit the Statement for approval of the full Conference. The statement was renamed "Commentary on the Primary Purpose of D.A.."

According to the official records, "the motion was not brought forward during Convocation due to time constraints." [2007 Annual Report, page 12] At the 2008 WSC in Salt Lake City, the Chair Carol B, incorrectly reported that the "primary purpose" statement had been presented to the Conference in 2007 and was defeated. [2007 Annual Report, page 10] In fact, this statement was never presented to the Conference for a vote.

For four years, the "San Diego Statement" was buried at the bottom of a page on the D.A. website as a statement which had been approved by the GSB. I believe this was deceptive, particularly for newcomers, since there is considerable confusion between the WSC, GSB and WSO. Many people thought this "primary purpose" statement was an official policy of the Debtors Anonymous. I thought that the San Diego Statement was dead and buried. I attended four WSC conferences, and never heard anyone mention it except as an historical curiosity.

I was a GSR at the 2012 WSC in San Diego, we were given copies of the Table of Contents and the Introduction to "A Currency of Hope" Second Edition. I was shocked when "The San Diego Statement" was mentioned by name in the Introduction. It was as if the (anonymous) author of the Introduction had exhumed the rotting corpse of the "San Diego Statement" and place it at

the head of the table at a brand new D.A. banquet. Because the rules did not permit us to change the wording of literature, our only choice as delegates was to accept the whole package or put off the new "Currency of Hope" for another year.

Several delegates were able to persuade the Conference to vote, by substantial unanimity, to eliminate all reference to the "San Diego Statement" by name in the new "Currency of Hope." [2012 Annual Report, page 17] Several months later, "The San Diego Statement" was removed from the D.A. website. I thought that the Statement was dead and buried, with a stake in its heart. 21 months later, I was able to open the first printed copy of "A Currency of Hope, Second Edition." I was shocked and dismayed to find reference to "The San Diego Statement" by name in the Introduction. The unanimous vote of the 2012 World Service Conference had been ignored. My question: What explains the inexplicable lifespan of this zombie statement? Could it be that the opinion of one person (the Chair of the GSB) takes precedence over the opinion of 100 members of the World Service Conference?

Frequent calls to the office are from Newbies who have looked at the website and have no idea where to begin. The website is confusing. People who call the office for the first time are in trouble and often in a state of anxiety. They need the information to be clear and simple. Often people call after hours and they need help.

The website could be more helpful and instructive to a newcomer. I regularly have to walk people through the first step such as printing the tools, or finding a meeting. A first timer looks at the meeting descriptions and has absolutely no idea how to pick one

for them. People ask regularly is it free. It's not that the information isn't in there, it's that the layout is not user friendly. There needs to be a frequently asked questions page, a newcomer's page, and something that is welcoming to the viewer. I wonder if there are those who may have looked at the website, couldn't relate and therefore didn't reach out. The web is a powerful tool that could strengthen the organization as a whole, as well as the debtor who still suffers. I feel strongly that this need is here and the ways to address it do not need to be in the distant future.

I believe the WSC Public Information Committee (PI) and the Hospital, Institutions and Prisons Committee (HIP) should combine to form one committee going forward. My concerns are as follows:

(1) The work the PI and HIP does is the same in that they are both seeking to reach the debtor that still suffers. They are both currently addressing similar audiences by utilizing the same means.

(2) PI and HIP: they both reach out to the public & institutions. They work hand in hand, literature is a shared method.

Institutions are found in the public arena, vice versa.

(3) With the combining of the two committees it helps alleviate some of the resources needed for each committee, i.e.,

(a) Two committees that have each been struggling to have enough people to do meaningful work would be combined. A single combined committee would be stronger than two marginal ones trying to "make it" on their own.

(b) One less meeting room would be needed at the annual WSC.

(c) One less WSC committee would require funding, which equates to savings.

(d) Conference delegates torn between joining PI or HIP would no longer have to choose.

(e) The lists of potential entities to reach out to are practically identical for the two committees. No need to have two separate committees contacting the same group of people.

In response, the conference committee wishes to thank you for bringing this concern to our attention. The John H. Scholarship Fund is limited by the amount of donations received from the DA membership during the year preceding the DA World Service Conference. Because the funds are limited, not every delegate can receive a partial or full scholarship. Moreover, dividing the available funds so that every applicant would get an equal amount, would not necessarily meet the delegate's needs.

For example: If the fund has \$7,000 and 60 delegates apply for scholarship assistance, each would get \$116.67. There are objective guidelines for awarding scholarships, approved by the WSC. We are unaware of any instances of favoritism or deviation from these. However, the concern expressed here alerts us to a need to better publicize these guidelines. We were unable to determine how to do so before the November 30th, 2014 deadline for submitting this response, but we intend to propose or adopt a solution before the next WSC in 2015. We also welcome any member's suggestions for amending the guidelines. We hope that this response addresses your concern.

Debtors Anonymous Brookline MA, saved my life. The group gave me the tools and fellowship to move through credit card debt and a subprime loan. Before I had the tool of awareness, I succumbed to Bank of America advertising and other banks. In the Great Recession, it has been approximated that 10,000 lives have been lost to suicide. Dartmouth just released a first time study of suicide linked to foreclosures. Bank of America predated on many people with subprime loans. In years past, they predated on Black Americans in the south and stripped them of their homes.

Tool # 9: Awareness: "We maintain awareness of the danger of compulsive debt by taking note of bank, loan, company and credit card advertising and their effects on us". When the D.A. Focus arrived, I was disappointed that D.A. places their money in Bank of America. My first thought was to remove myself from the fellowship, because of the clear hypocrisy of any organization like Debtors Anonymous that teaches the members to avoid debt at all costs, and be willing to go to any lengths necessary to not debt one day at a time. It is my hope that through a thorough inventory, we may discover a bank that is more in alignment with our steps, tools, and traditions. In order to not debt one day at a time, and be willing to go to any lengths necessary, sometimes convenience is too costly.
