Announcements

Press release announcing the 40th Anniversary of Debtors Anonymous was sent around the world at 1 minute after midnight on April 4th. Just two hours later, we received our first report that the press release was picked up by 474 print, broadcast, and online outlets. In the first two hours, the release hit the U.S., Canada, Chili, Columbia, and Argentina.

At the five hour mark, we hit China and Malaysia. A few hours later, Asia, Australia, Hong Kong, India, Indonesia, Japan, Mainland China, more outlets in Malaysia, the Philippians, Singapore and Vietnam. A little later, Brazil, France, Macao, and Taiwan. The reports are still coming in, with the final report expected at the one month mark.

<u>Audit</u>

The Audit Committee continues to oversee to the financial procedures of the D.A., as per New York state law guidelines.

Recent actions by the committee include:

Recommended to the board's Nominations committee that the full General Service Board (GSB) receive a presentation regarding our password protection policies and procedures, with possible suggestions in how to continually protect the integrity of all and passwordpasswords This protected documents. presentation was made to the GSB by Jon L., Appointed Committee Member to the board's Information Technology Committee, at the GSB face-toface meeting in January. It was well-received by all, and a better understanding was developed in how we can ensure not only our financial integrity, but also in any other areas where passwords are required.

Forwarded a motion to the GSB to establish a reengagement policy relating to acquiring a C.P.A. firm to conduct the annual review of our year-end financial statements and to prepare the GSB's federal and New York state tax returns. The policy, which was approved, states that the GSB will request new bids for this service every 5 years.

The committee also responded to three Issues and Concerns. One of them involved the meeting closing statement currently in use by many groups. This statement has been heavily borrowed from the Al-Anon closing statement. Legal Affairs brought a motion to the Board to remove this statement from our literature. This motion passed and the statement will be removed when literature comes up for reprint. The chair of the General Service Board also sent an eNews to the members requesting that the groups consider discontinuing the use of the statement.

Nominations

The Nominations Committee is continuing to encourage D.A. members who are available, and eligible to come forward to serve their Fellowship, as Class A and Class B trustees. Our Bylaws allow for 15 trustees, which comprise 10 Class A's, and 5 Class B's, to serve on the General Service Board. At this time, the ratio is 7 Class A's and 4 Class B's. We have no pending Class A applications, but do have 1 pending Class B application. As stated during the 2015 WSC, it is essential to the spiritual health of the Fellowship, that their members represent the 2/3 ratio set forth in the original founding of the GSB. So, please review if you or another member could step forward to serve the D.A. Fellowship, at this level. It is a way for a member to give back to a Fellowship which has helped you achieve the recovery in all areas of their life. The committee also reviews the DAGSB Bylaws, and makes suggested revisions that go to the full GSB for approval. One item of business they are researching concerns the policy, and

procedures relating to the Appointed Committee Member. The committee is also receiving letters of intent from the current trustees who are willing to serve as officers of the D.A. Corporation and GSB for the 2016-2017 term. These will be submitted to the GSB, for approval, during their 2016 face- to- face meeting prior to the 2016 WSC.

Public Information

Cooperation, coordination, communication, mutual respect, and trust well defines the relationship between the World Service Conference (WSC) Public Information Committee and the General Service Board (GSB) Public Information Committee.

GSB PI has really played a supporting role, working hard to vet the many proposals coming from WSC PI and its subcommittees. Several of the initiatives (see the WSC PI report) volleyed were amond the committees and the board, with frequent emails, phone calls, and special meetings; all to find ways to better reach the still suffering debtor.

One of the more far reaching initiatives was the development and publication of a press release acknowledging the 40th of Debtors Anniversary Anonymous. In preparation for the GSB PI hosted a release. refresher media contact training. Even this was a cooperative effort, with a board member and the chairperson of WSC ΡI serving as CO-The press release presenters. was distributed worldwide on April 4th. We will certainly report the results of this venture into the

realm of press releases in a future issue of the D.A. Focus.

Additionally, the GSB PI Committee takes on the responsibility of sending letters of acknowledgment to media outlets who mention D.A. in an article or story. This can sometimes, and has included occasions to share our traditions around maintaining anonymity.

The GSB PI committee continues to seek an Appointed Committee Member...or two. The primary role of an ACM serving as a member of the GSB PI committee is to schedule and conduct periodic Media Contact Training, and help keep the list of trained members current. GSB Literature Publications Committee

The GSB Literature Publications Committee is responsible for the publication, revision, and reprinting of D.A. literature, including books, pamphlets, and other items such as bookmarks and newcomer packets.

We have eight projects actively underway at this time, including six new literature pieces and two existing pieces that are being updated.

Certainly, the item at the top of the list is *The Twelve Steps, Twelve Traditions, and Twelve Concepts of Debtors Anonymous*, sometimes referred to as the 12x12x12. We are in the final prepress activities for the new book, and hope to be sending our printing files to the printer by the end of March. If we meet that target, the book should be available for sale in May.

You may be wondering how a "12x12" became a "12x12x12." The answer is simple: at the 2015 World Service Conference, a motion was passed to expand the concept of the Twelve Steps and Twelve Traditions book to also include the Twelve Concepts of World Service, which had previously been printed in The Debtors Anonymous Manual for Service. Just as the Steps provide guidance for individual recovery Traditions and the provide guidance for group unity, the Concepts provide guidance for coordinating and administering our Fellowship on a worldwide basis.

The new book will be printed in both paperback and hardcover formats. When we receive the books at the General Service Office, and are thus ready to start accepting orders, we will post an

announcement about the book, along with a New Literature Order form, at <u>www.debtorsanonymous.org</u>. The books will be sold as single copies, or in bulk packs of 10 or 20 copies, with discounts for the bulk packs.

Publishing this book will be a landmark event for our Fellowship, and is happening only because of the dedicated service by many D.A. members over the last 15+ years. Thanks to all who served!

Conference Committee

The WSC Conference Committee has created four subcommittees. One is working, with the help of our Board Liaison, on clarifying the relationships and responsibilities of our committee, the Board's Conference Support Committee, and the local Host Committee set up for each Conference. All three play a role in putting on the WSC, want and we to minimize misunderstandings about who is -and should be -- doing what.

The Tech Committee and International Caucus have in the recent past been seeking to effectuate a way for GSRs and ISRs outside North America to participate in the Conference remotely via video. We have a subcommittee looking into the non -technical challenges, such as anonymity and credentialing of voting delegates.

The Convocation has approved running a trial at this year's WSC of giving delegates an option of receiving the conference documents that go in our thick binders digitally, and another subcommittee is monitoring that and preparing means to evaluate the experiment afterwards Finally, a substantial majority of our committee sees problems -perhaps unnecessarily imposed by our current structure -- from having WSC committees work throughout the year on projects

throughout the year on projects but be unable to present their work to Convocation. The view is that committees are relegated to hoping that the successor committees, in the few hours of meetings before Convocation, will be able to get up to speed on the disbanded committees' recommendations and carry them motions. forward as Α subcommittee is studying this question and has prepared a draft survey of delegates now serving on committees, to gauge others' concerns and thoughts about solutions. possible

WSC Literature Committee Update – March 2016

2015-2016 The Literature Committee is an enthusiastic, dynamic group of 15 members. We continue to work closely with the General Service Board's Literature Publications Committee and other GSB and WSC Committees in all levels of creating DA conference-approved literature.

Participation on our monthly calls has been strong and steady. We also have additional meetings during the month for subcommittees on the 'Basic Text' outline and have started weekly 'drop-in' reading and discussion meetings to work on in-process literature.

The WSC Literature Committee responded to all twenty Issues & Concerns that were assigned to us at last vear's World Service Conference in Portland. We continue to prepare responses for several Issues & Concerns that the GSB Literature Publications Committee referred to us and these will be ready for the 2016 WSC in Dallas. The topics Issues & presented in the Concerns were wide-ranging and generated lively and passionate discussions among the members.

Literature Committee continues to work on other projects and include the following: preparing an outline for the Debtors Anonymous 'Basic Text,' creating a writing to replace the 'Preamble,' and developing an outline for a Beginner's Meeting Format The Committee has considered, but tabled for now, work on a DA Step Study Workbook. Lit Com has reviewed and provided feedback on 'inprocess' projects. including manuscripts and other pieces of literature, as requested by the GSB **Publications** Literature Committee.

We have reviewed the revised 'Recoverv from Compulsive Spending' pamphlet and the first draft the 'BDA Signposts and Tools' pamphlet. We anticipate work on other pamphlet revisions and drafts, including a new pamphlet on the 'Twelve Promises' and additional pamphlets from BDA.

Shown here is a comparison between totals for the first eight months of the 2015–16 fiscal year (July 1, 2015–February 29, 2016) and the first eight months of the previous fiscal year (July 1, 2014–February 28, 2015). Five points should be noted:

1. Literature sales are up \$15,741.51 with respect to the same period in the previous year. This reflects sales of the book *The Twelve Steps of Debtors Anonymous*.

2. Group contributions are down \$5,789.93 during the current period compared with last year, or approximately 18%.

3. The lower Board-related expenses in the current period are due in part to the there being fewer trustees than in the comparable period.

4. The lower office expenses in the fiscal year 2014–15 were due to the absence of an office manager during part of the period.

5. The difference in WSC income and expenses is the difference between the estimated cost of the Conference, which forms the basis of the registration fees, and the actual costs.

Over the years, however, a felt that it would represent an unwarranted number of attempts to make that particular format "dumbing down" of the program, and a proposal Conference-approved for D.A. as a whole have to change the name was overwhelmingly defeated.

A fierce debate over the language of Pressure particular format imposed on them. Groups and Meetings raged at several World Service Conferences during the 1990s, with partisans of "relief" gradually gaining ground. By the 1997 Conference in Los Angeles, those in favor of "relief" had gained the upper hand, and a motion to change the tool and the pamphlet carried by a substantial margin. It took a year or two, however, for the existing stock of pamphlets at sell out, at which time the Pressure Groups and Pressure Meetings pamphlet was reprinted with the new name.

The 1997 vote was the last formal action ever committees, taken by the Conference on the names, although Intergroups. there has continued to be considerable diversity practice, once considered in the fellowship over what to call these uncommon. venerable institutions. Regional differences remain prominent. For example, many old-timers in the New York area continue to use the old terms "Pressure Groups and Pressure Meetings". In the Washington, DC area and some states of the Upper Midwest the term "P-Groups" is common. And they are often shortened to "PRG and PRM" in some areas, with confusion resulting over which is the "group" and which is the "meeting".

Various attempts have been made over the years to "standardize" the practice of PRGs/PRMs in wreckage of the past. D.A. The "Pressure Relief Groups and Pressure Relief Meetings" pamphlet, D.A.'s second-oldest piece of published literature and one of its consistent best sellers over the years, does not attempt to enforce a common format for members, only some basic general principles. Many members have written their own individual "guides" for PRGs that are used in different parts

of the U.S., with quite a bit of variation between and regions.

One type of Pressure Group that was for decades extremely common in D.A. is the socalled "Treasurer's Pressure Group", conducted for D.A. service committees, groups, and Intergroups. While extremely common the in the 1970s, 1980s, and 1990s, they have virtually disappeared today. Until the very late '90s, the Treasurer of the General Service Board and of board committees would put together several "Treasurer's PRGs" a year to help guide board finances. It does not seem likely, however, that the Group/Pressure Meeting. Pressure under whatever name it might be called, will disappear Compulsive debtors from the D.A. scene. coming into the fellowship for the first time will always feel the crippling shame and awkwardness of the debting lifestyle, and will always need the encouragement and guidance of more experienced members as they move steadily to stop incurring any new unsecured debt and clean up the financial and emotional
