Friday Evening

In the Ouestion and Answer Session with the GS Board and Committee chairpersons, questions were answered directly or referred to the appropriate Committee for consideration. I asked about the possibility of allowing a GSR to have more than one vote when he or she represents more than one meeting. The question was answered that at this time each delegate is entitled to one vote; however, the matter was brought up in the Conference Committee meeting the next day. The idea was tabled for this Conference, but the seed was planted regarding the subject of electoral votes in the future.

Another question was, "Are there any guidelines regarding prioritization of financial responsibility to the GSO versus one's local Intergroup?" The answer from the Board member in charge of Finance was that both are equally important and that priorities vary from time to time.

Due to the popularity of the question and answer session, future Conferences will extend the time for this exchange of information.

Saturday: Committee Workshops

The various committees met, and each committee reported back to the Conference the results of their meeting. Summaries of Committee activities follow:

Fellowship Communications Committee. This Committee is planning to produce the first DA World Service **Directory of Meetings and Contacts** (see article on page 3) in 1990. They now have a mailing list of 100 meetings around the world (out of a known 200) and are setting up a mechanism for keeping this list up to date, based on the information GSRs submit to the GSO.

Literature Committee. This committee presented "Suggested Guidelines for Committee Approval of Literature," making approval a standard two-year process. Five drafts of literature were presented "for comment." They will be presented "for approval" at the next World Service Conference. Also, it's important to note that one does not have to be a GSR to participate in the development of literature. There is also a Big Book Committee starting, which one can contact via the GSO (see address on page 1).

Public Information Committee. This committee revised its manual entitled "Slow is the Way to Go." The committee set up guidelines for the formation of local Public Information subcommittees to help them in responding and reaching out to the debtor who still suffers.

Finance Committee. This group decided to have an unaudited recap and bank statement sent guarterly to GSRs with a total of each account and recap of earnings and expenses. They will work on a pamphlet on group spending plans for contributions (i.e., to GSB Development Fund, Intergroup, sending GSRs to Conferences).

Conference Committee. An interim Conference Charter was presented and passed. San Francisco and Boston were presented as potential sites for the 1991 Conference; San Francisco was chosen. A flyer on the role of the GSR was presented and accepted by the Conference and will go into registration packets this year.

The committee also voted to extend the 1990 Conference in Chicago by one extra day and to have an open speakers meeting as well as some closed sharing meetings.

Service Committee. This committee is developing written guidelines for service, including a definition of what service is, a listing of offices, terms of each office, and requirements to fill each office. They are also devloping guidelines for handling long-distance sponsorship for loners and fledgling groups.

Sunday: The Convocation

The conclusion of the business of the Conference took place at the 8:30 am "Convocation." Sunday morning did come a little early for those of us who had danced the night away at the Debtor's Ball!

Issues brought before the Convocation were handled with a strict yea or nay vote. Some GSRs were frustrated because they had expected that the Convocation would follow Parliamentary Procedure. This frustration culminated at one point with the Chairperson asking a Committee to caucus andto clarify their intent concerning the point in question. She asked the rest of us to take a tenminute break.

When the session resumed, there was still discord, so the Chairperson paused for a moment of silence. She said she felt it was important to have the group conscience, rather than

just a slendar majority vote, be reflected in the decisions of the Convocation.

The Chair asked a series of questions of the differing factions in order to discern the nature of the conflict. As a result of her information gathering, a solution was achieved. This integration of the spiritual with the pragmatic, this reverence for group conscience, combined with the commitment to stay on schedule and to take care of business was one of the most inspiring moments of Conference.

What impressed me here and during the Conference as a whole was everyone's willingness to be who they were, to have feelings and not ignore or discount them, and to hang in there while working hard at a working Conference. That we could do so in loving, effective, and creative ways was as important to me as anything else that came out of the Conference.
