There ARE Spiritual Solutions! HOSTING A D.A. CONFERENCE One chairperson's experience, strength and hope

I have had the wonderful experience of hosting a D.A. conference. For me it was one of the most rewarding and fulfilling opportunities of my life. As I listen to the Do D.A. Day tapes, all the love, fellowship and recovery are relived. I want to share a few of my experiences for future host committees and chairpersons. Please take what you like and leave the rest.

First, you need to have a Godinspired Vision of hosting. Share your vision with your home group to see if there are like-minded folks in your area. If so, be sure to send one or two people to the following conference and have them be on the Conference Committee. Also, contact previous hosts, like myself, for ideas of what is really involved.

To be honest, it was never "My" vision to host this conference. No

sir, I was content helping with Do D.A. Day and being a co-chair for this committee only. After all, I didn't want all the responsibility and work involved with being THE CHAIRPERSON. Well, HP had a Vision for me. Being of service in this capacity was something God wanted me to do so I could grow and grow and grow. At first I was just a liaison to the Board. Then I made a decision to go to any length to do whatever it took to fulfill our commitment to D.A., and with one particular Board member's blessing and help we held the Vision. I was filled with fear at times--self-pity and grandiose notions at others. I called for prayer support often, got on my knees to turn over my will often and cried, all along doing the footwork (WORK, and lots of it!).

Across-The-Board Literature Price Reduction

Effective January 1, 2001, the price of ALL D.A. pamphlets will be reduced by $50\ \text{cents}$ each.

The price reduction was approved at the annual meeting by the General Service Board (GSB) and responded to a long-felt need among D.A. members. After successfully testing several new prices during the summer, the Trustees unanimously approved the reductions. They hope that the price reduction will encourage both new—and current—D.A. members to read more D.A. literature that can help them enhance their recovery.

The new prices will be reflected in new literature order forms and a new catalog of D.A. publications available around the first of the year.

The Public Information Committee has plans to make the manual available via the upcoming version of the Debtors Anonymous Website.


Three new literature pieces approved at 2000 World Service Conference in Albuquerque!

The Twelve Concepts for D.A. World Service

D.A. provides a solid basis of four legacies with which debtors are guided in their recovery. These four are the Tools, the Steps, the Traditions, and the Concepts. The tools are our "standard operating procedures," practical exercises in recovery designed to bring clarity and order to our confusion about money and its role in our lives. The Steps provide spiritual guidance for each individual to grow in one's personal recovery process. The Traditions provide direction for working in unity and harmony in order to support all members of the groups and the D.A. Fellowship as a whole. The Concepts of Service support our recovery as we serve each other in business matters in order for the Fellowship to grow and to reach the still suffering debtor.

The Concepts are more than "rules" of business management. They are the global guidance for the spiritual caring and effective management of D.A. by the Trusted Servants in meetings, intergroups, areas, and D.A. worldwide.

Just as the Twelve Steps are guides for personal recovery and the Twelve Traditions are guides for group unity, the Twelve Concepts are guides for World Service. These Concepts serve as a path for Twelfth Step work on a world service level, and show how the D.A. groups, the World Service Conference, and the Debtors Anonymous General Service Board work together to carry recovery in D.A. to the still-suffering debtor.

- The ultimate responsibility and authority for Debtors Anonymous World Services should always remain with the collective conscience of our whole Fellowship as expressed through the DA groups.
- The Debtors Anonymous groups have delegated complete administrative and operational authority, except for changes in the 12 Steps and 12 Traditions, to the Debtors Anonymous General Service Board, who will be the voice and conscience for the whole Fellowship.
- 3. As a traditional means of creating and maintaining a clearly defined working relationship between the groups, the World Service Conference and the DA General Service Board, it is suggested that we endow these elements of world service with a traditional "Right of Decision" in order to ensure effective leadership.
- Throughout our Conference structure, we maintain at all levels a traditional "Right of Participation" ensuring a voting representation.
- Throughout our world service structure, the Right of Appeal protects minority opinion and assures that they may be heard.
- The Conference acknowledges the primary administrative responsibility and other duties of the Debtors Anonymous General Service Board. The Trustees delegate full authority for routine management of the DA headquarters to its executive committee.
- 7. The Conference recognizes that the Charter and the Bylaws of the Debtors Anonymous General Service

World Conference Statement on Abstinence and Solvency Terminology

The World Conference in Albuquerque, NM adopted a new statement about abstinence and solvency for the Fellowship of Debtors Anonymous (D.A.), proposed by the Literature Committee, by a 90-4 vote. The new statement reads: "The process of solvency begins the day we abstain from incurring new, unsecured debt one day at a time."

It retains all senses and definitions of the word "solvency" as a state of being that one can reach or achieve. It retains the action of the verb "abstain," which means to refrain from doing something that could harm us. And it focuses on the most important aspect of D.A. membership: not incurring new unsecured debt one day at a time.

This statement was adopted after many years of discussion among D.A. groups during which different groups emphasized different terms. It is hoped that the new statement will be embraced by all groups so the Fellowship may remain focused on our primary purpose: to carry the message to the compulsive debtor who still suffers.

Board serve as governing documents and that the Trustees have legal rights, while the rights of the Conference are spiritual, rooted in the Twelve Traditions. The Concepts and the Charter are not legal instruments.

- The Debtors Anonymous General Service Board of Trustees assumes primary leadership for larger matters of overall policy, finance, and custodial oversight and delegates authority for routine management to the General Service Office.
- Good leaders, together with appropriate methods for choosing them at all levels, are necessary. At the world service level, the Board of Trustees assumes primary leadership for DA as a whole.
- Every DA service responsibility should be equal to its service authority as defined by tradition, resolution, or DA's Charter.
- 11. While the Trustees hold final authority for DA World Service administration, they will be assisted by the best possible staff members and consultants. Therefore, serious care and consideration will always be given to the composition, selection, induction to service, rotation, and assignments of special rights and duties for all staff with a proper basis for determining financial compensation.
- 12. The Conference of Debtors Anonymous will observe the spirit of the Traditions, taking care not to become powerful and wealthy; having sufficient operating funds with a prudent reserve; having no authority over any other members; making important decisions by discussing and voting on issues; not acting in a punitive way; not inciting public controversy; never performing any acts of government; and, finally, always remaining democratic in thought and action.

Notes from the General Service Board

Four new Trustees from four geographic regions were ratified for three-year terms at the 2000 World Conference in Albuquerque, NM in September. Their ratification brings the number of Trustees to an even dozen, the first time in many years that the GSB has had that many Trustees.

Special Note: The GSB wishes to thank former Chair Chris F., from Winston-Salem, NC, for her incredible seven years of service as a Trustee. Chris served as Chair twice. She also served as Vice Chair and Treasurer.


